DIRECTIONS:

- 1. You will be registered in the No Knock Registry maintained by the Township Clerk.
- 3. Once you register it is not necessary to register again. Should you wish to be removed from the list, contact the Township Clerk's Office and your address will be removed
- 4. The **NO KNOCK Sticker can be picked up at the Township Clerk Office**. Place this near your door in a window somewhere it will be visible by anyone who may knock on the door.
- 5. The Registry will be updated on the 1st of each month to be distributed to each person who has a valid Peddlers/Solicitor's License each month as well. They will also receive a **list of addresses only** of who is registered so they do not knock on your door. They will also receive one of the stickers as well.
- 6. **Violations of the No Knock Registry should be reported to the Police Department and the Township Clerk.** Attempt to obtain the information from their vendors permit. Contact the Township Clerk's Office if you obtained information and file a report. If you are unable to do so **Notify the Police Department so they may locate the person if still in the area.** Depending on the circumstances, the process may begin to warn, revoke the license, or file a court complaint. A court complaint may require your testimony to support the court complaint.

EXEMPTIONS:

This No Knock Registry **shall not** apply to:

- **A.** Any veteran or exempt fire fighter who holds a special state license.
- **B.** Any person soliciting a vote or support for any political candidate or program.
- <u>C.</u> Any person soliciting for a bona fide charitable, religious, patriotic, community service or philanthropic purpose or organization.
- **<u>D.</u>** Any person engaged in delivering wares, goods or merchandise or articles or things in the regular course of business to the premises of the person ordering or entitled to receive the same.
- **E.** Wholesale salespeople calling on businesses.
- **<u>F.</u>** Public utilities or their employees, provided that such public utility is subject to regulation by the State Board of Regulatory Commissioners, and provided that such employees display the identification badge or card issued by their employer.
- **G.** Any person selling fruits or farm products grown by himself/herself, with or without the help of others.
